

MTTIA Conference Members Code of Conduct

The purpose of Midwest Teachers of Transportation and Industrial Areas (hereinafter, "MTTIA"), MTTIA conference, and related activities, (hereinafter, "the Event") are to create a forum for MTTIA members to participate in the affairs of the events, members are to advance the common interests of transportation industry and the companies that partake in educational programming. Network with industry colleagues, strengthen existing business relationships, and identify new business opportunities.

To further these purposes, and to ensure MTTIA fulfills its contractual obligations to its host facilities and exhibitors, as well as to protect members, guests, vendors, volunteers, speakers, sponsors, and exhibitors (hereinafter, collectively, "Event Attendees"), the Association has adopted the following conduct guidelines (hereinafter, the "Attendee Conduct Guidelines") that shall govern the Event. The Attendee Conduct Guidelines shall apply in all areas licensed, leased, or rented by MTTIA for the Event. The Attendee Conduct Guidelines shall be distributed to Event Attendees in the conference registration kit. Event Attendees must sign and consent to these Attendee Conduct Guidelines below.

By being admitted to the Event, Event Attendees agree to abide by these Attendee Conduct Guidelines. MTTIA reserves the right to eject any individual or company from the Event who violates these rules or who otherwise acts in a manner inconsistent with the purpose of the Event. In the case of ejection from the Event, the event registration fee will not be refunded.

By proceeding with registration, you agree to abide by the following Attendee Conduct Guidelines for the Event:

Attendee Conduct Guidelines

The purposes of Midwest Teachers of Transportation and Industrial Areas Events, and related activities, are as follows:

1. To create a forum for MTTIA members to participate in the affairs of the association;
2. To advance the common interests of transportation industry companies;
3. To partake in educational programming;
4. To network with industry colleagues;
5. To strengthen existing business relationships;
6. To identify new educational and business opportunities.

To further these purposes, MTTIA has adopted these guidelines to govern the Event. Every attendee shall be considered to have notice of these guidelines and, by being admitted to the Event, agrees to abide by them. MTTIA reserves the right to eject any individual or company from the Event who violates these rules or who otherwise acts in a manner inconsistent with the purposes of the event. In such case, the event registration fee will not be refunded.

- 1) Every Event registrant shall receive a badge from MTTIA. Individuals without official badges shall be denied Entry to the event. Badges are not transferable.
- 2) Event attendees shall be respectful of other attendees and shall not engage in conduct designed to intimidate or harass any individual or company, or that creates an unduly hostile or inflammatory atmosphere.
- 3) Event attendees shall, at all times, act professionally, respectfully, and in furtherance of the purposes of the Event.
- 4) No person under the age of 18 will be admitted to the Event without the express permission of a duly authorized agent of MTTIA.
- 5) Event exhibitors and Event sponsors have compensated MTTIA for the opportunity to communicate with event attendees. Therefore, in fairness to our exhibitors and event sponsors, only literature approved or published by MTTIA may be distributed in the registration area, meeting rooms, exhibit areas, and outside the exhibit areas. Non-approved items will be removed.
- 6) Individuals or companies that have not purchased Event exhibit space or sponsorships may not solicit business or engage in outreach to meeting attendees within or near the Event areas. Any individual or company found to be conducting business or engaged in public outreach as outlined in the aforementioned manner is in violation of these rules and shall be removed from the Event areas.
- 7) Event attendees are prohibited from displaying any unauthorized signs in the Event areas. Only MTTIA or bona fide exhibitors and sponsors may display signs in the Event areas. All unapproved signs will be removed.
- 8) Attendees understand and consent to MTTIA's use of their image, likeness, appearance, name, and voice (hereinafter "Image") in promotional and marketing materials used for a commercial or fundraising purpose for the benefit of MTTIA. This consent will apply to all Images taken or commissioned by MTTIA during my attendance at the Event, and will apply to the use of those Images at all times both during and after my attendance at the Event. By attending the Event, all Attendees waive any claims to compensation or damages based on the use of their Image by MTTIA for commercial or fundraising purposes.
- 9) The elected executive board members of MTTIA shall be the sole decision maker in interpreting and enforcing these guidelines. Any decision made by the executive board members regarding violation of these rules or to eject an attendee or company from the event shall be final. MTTIA reserves the right to grant exceptions to these rules in extraordinary circumstances and the decision to do so shall not constitute a waiver of the future applicability of any rule.
- 10) These guidelines may be modified or changed at any time without notice to Event attendees.
